

Hutchinson High Seniors may apply for the following:

Your **local scholarship application (LSA)** must be submitted to the counseling center in order to apply for the following scholarships. For EACH local scholarship you wish to apply for, *a separate request form must be completed*. Be sure to attach any required forms such as personal statements and reference letters. All parts of the scholarship must be included before your application can be submitted to the selection committees.

HCC scholarship priority deadline: FEBRUARY 15

Whether attending HCC is definite or a back-up plan, you should complete the HCC application for admission and the HCC scholarship application. There are many scholarships that require the HCC application alone or in conjunction with the LSA in order for you to be considered. Go to your DragonZone and choose the finance tab to find the scholarship application.

CLASS OF 1960 WHITESIDE ALLAGAROO Due date: FEBRUARY 19

This award is for \$1500 (\$750 for each of the first two years of college). The applicant must demonstrate leadership, community involvement, academic success, and financial need. Include a personal statement pertaining to your college plans, career goals, financial need, and any other information which might help the committee know you and your situation better. Applicants must also provide three letters of reference: one from an HHS teacher, one from someone outside HHS, and a third from a reference of choice, such as an employer.

The following scholarships are for students planning to attend Hutchinson Community College, and are administered through the HCC Endowment office. In order to be considered for these scholarships, you must have completed the LSA, the HCC scholarship application including a personal statement, and the request forms in the counseling center.

DUE DATE: FEBRUARY 15 for all except Doherty, which is March 13.

#### HCC CLASS OF 1965 SCHOLARSHIP

Two awards of \$1250 each. Applicants must be enrolled full time. Academic achievement and financial need will be considered.

#### HCC GLOVER FAMILY SCHOLARSHIP

This scholarship is awarded to an HHS graduate who attended Lincoln Elementary School for at least three years. Minimum GPA of 2.0 and plan to attend HCC full time. This award covers tuition of up to 16 credit hours per semester.

#### HCC D.G. LETT MASONIC LODGE #30 SCHOLARSHIP

Eligible applicants are minority students with a solid academic history, citizenship, and financial need. Preference will be given to graduates of Reno County schools. Award is for \$400 for the academic year.

#### HCC JOHN H. (JACK) CATON MEMORIAL SCHOLARSHIP

Applicant should have contributed to their school/community through leadership and volunteer activities. Academic achievement and financial need will be considered for this \$1000 scholarship.

#### HCC D. STEWART & LORNA M. OSWALT MEMORIAL SCHOLARSHIP

\$1000 will be awarded to one male and one female student who have demonstrated a commitment to their education.

#### HCC HISPANIC HERITAGE SCHOLARSHIP

Full-time student of Hispanic heritage with a minimum GPA of 2.00. \$1600 per year for up to two years. Include a personal statement and one letter of

recommendation from a high school counselor, teacher, principal, or activity sponsor.

### **AMERICAN LEGION LYSLE RISHEL POST 68**

Must show financial need. Preference to children or grandchildren of veterans who belong to Post 68. Student must have minimum 2.00 GPA and exhibit leadership and citizenship. To be considered, your HCC personal statement must state that you are applying for this particular scholarship.

### **DOHERTY SCHOLARSHIP Due date: March 13**

Hazel Doherty served at Lincoln Elementary School for 25 years, first as a teacher, then as a reading specialist. She has established this scholarship for former Lincoln students. Preference will be given for those with demonstrated financial need, with good citizenship and strong references. Minimum 3.00 GPA. Submit three letters of reference, with one from a Lincoln teacher or staff member. Scholarship is for \$1000 for first semester.

### **BERKLEY-CALHOUN VOCAL MUSIC DUE DATE: MARCH 13**

\$500 for a student who participated in vocal music at least two years in high school, expresses an intent to major in vocal music, and submits an essay explaining their choice and demonstrates financial need. Minimum GPA of 2.50. Applicants are required to audition with a panel of judges. The essay should be turned in to the counseling office and the audition will then be scheduled for late March or early April.

**JENNIFER A. GOODMAN SCHOLARSHIP DUE DATE: MARCH 13**

\$500 to a student pursuing any post high school training, especially vocational training such as cosmetology or welding. Preference given to those with a 2.00-3.00 GPA. Money intended for books and supplies, not room and board.

**CLASS OF 1961 SCHOLARSHIP DUE DATE: MARCH 13**

Given in honor/memory of deceased classmates of the HHS class of 1961. The recipient will receive \$1500/year for two years if full time status and grades have been maintained each semester. Awarded to a student attending a college or university in Kansas who meets the following criteria:

Has been on the honor roll at some time during high school and has the potential to achieve good grades in college; can show involvement in school and/or community; and can show financial need. Holding a job during high school while keeping up grades is a plus. Submit a personal statement or resume listing accomplishments, future goals, and explanation of financial situation.

**CLASS OF 1968 SCHOLARSHIP DUE DATE: MARCH 22**

One \$2000 scholarship (\$1000 per year for two years) to a student planning to attend a regents or private college or university in Kansas. The selection committee will consider the following criteria: Financial need; minimum 3.00 GPA; not been awarded more than one other local scholarship; and participation in at least one extracurricular activity and/or holding a job. Applicants who demonstrate good citizenship, goal orientation, and leadership potential should receive favorable consideration. Submit a personal statement that reflects the above criteria.

**SHELTER INSURANCE FOUNDATION DUE DATE: MARCH 22**

One \$2000 scholarship will be awarded. The selection committee will consider the applicant's scholastic achievement, participation and leadership in school and community activities, citizenship, moral character and educational goals. Submit a personal statement.

**CLASS OF 1953 EDUCATIONAL GRANT DUE DATE: APRIL 4**

Priority is financial need. Preference will be given to someone attending a Kansas college. Must have unweighted GPA of 2.50-3.50. Submit three letters of reference. One scholarship of \$1500 will be awarded.

**MARTY CASEY FACS EDUCATOR SCHOLARSHIP DUE DATE: APRIL 4**

\$250 per year, renewable for four years. Available to anyone pursuing a career in the field of Family & Consumer Science, which includes FACS education, early childhood education, social work, marriage and family therapy, counseling, psychology, and culinary arts. Submit a resume and personal statement.

**MELISSA YOST MEMORIAL SCHOLARSHIP DUE DATE: APRIL 4**

\$500 a year for four years for a student who has been diagnosed by a physician with a potentially life threatening chronic illness OR is the sibling of a student who has been diagnosed with a potentially life threatening chronic illness. Submit a personal statement about dealing with a chronic illness, and a written statement from a physician stating the diagnosis.

### **CLASS OF 1962 SCHOLARSHIP DUE DATE: APRIL 4**

Two \$1000 scholarships will be awarded to students planning to attend a regents college or university in Kansas. The selection committee will consider the following criteria: Need for financial aid; minimum 3.00 GPA and in the top 20% of the Senior class; and participation in at least one non-athletic extracurricular activity. Applicants who demonstrate good citizenship, goal orientation, and leadership potential should receive favorable consideration. Submit a personal statement that reflects the above criteria.

### **COBERLY/TWEITO MEMORIAL SCHOLARSHIP DUE DATE: APRIL 4**

Two \$4000 scholarships (\$1000 per year for four years) to students in the top 20% in their class. Include a personal statement which includes an explanation of your financial situation and special circumstances such as obstacles you might have overcome or issues you face going forward.

### **NEA TEACHERS SCHOLARSHIP DUE DATE: APRIL 10**

One scholarship will be awarded to a student planning to become a teacher. Must have an unweighted GPA of 3.00. Submit a resume along with an essay entitled "Why I want to be an educator". \$500 for one year.

### **CAROL J. WONDERLICH SCHOLARSHIP DUE DATE: APRIL 10**

One \$1000 scholarship given to a student who plans to major in education and who exemplifies qualities of an outstanding classroom teacher. Applicants should submit a personal statement sharing what prompted the decision to pursue a career in teaching.

#### KADPF SCHOLARSHIP    DUE DATE: FEBRUARY 15

The Kansas Association of Directors of Plant Facilities awards three academic scholarships and one technical scholarship of \$1000 each. For children of non-instructional support staff at K-12 or secondary schools (people who work in food service, custodial work, transportation, or buildings & grounds). Must attend college or technical school in Kansas. Applications available in counseling office.

#### WESTAR ENERGY    DUE DATE: MARCH 1

For students pursuing a degree in electric power, power plant technology, wind energy, industrial technology, or line work. Four scholarships at \$3000 for up to two years. Applications can be found at [www.WestarEnergy.com](http://www.WestarEnergy.com) by clicking on “scholarship opportunities” under the community programs tab at the bottom of the home page. 18 ACT and 2.50 GPA minimum.

#### KEY CLUB SCHOLARSHIP    DUE DATE: MARCH 12

Kiwanas Club of Hutchinson will award three Key Club scholarships worth \$250, renewable for a second year to students in good standing as members of KEY Club. Submit a Kiwanis scholarship application available in the counseling office.

### **DENNY HART FAMILY ATHLETIC SCHOLARSHIP DUE DATE: MARCH 14**

\$1000 for first semester at any accredited college or university. Established by Janie and Shelby Hart in honor of Denny Hart for his commitment to helping young people. An applicant should be Reno County graduating senior, highly involved in athletics, demonstrate clear commitment to the community through involvement in activities outside the classroom, demonstrate financial need, and have a minimum GPA of 3.00. Submit the application (available in the counseling center) along with three letters of reference and a brief essay describing your commitment to your community and how you have demonstrated a willingness to help others. Youth friends, community service, mission trips or other areas of involvement are types of commitment for which the committee is looking.

### **HUTCHINSON NEWS FUTURE JOURNALIST DUE DATE: MARCH 15**

\$1000 for one year to a senior with a minimum 3.00 GPA who intends to major in journalism or photojournalism at an accredited college or university. For more information and how to apply, google "Hutchinson News future journalism scholarship".

### **MID-KANSAS COOP ASSOCIATION DUE DATE: MARCH 15**

MKC will award ten scholarships of \$1000 each. Any senior who plans to attend an accredited university, college or technical school may apply. Hutchinson High School had winners in 2010, 2013, and 2015. It is an excellent opportunity to be recognized if you have demonstrated a balance of academics, school activities and community service. One scholarship for \$500. Must be enrolled in vocational program at HCC. Based on scholastic record and financial need. Applications in counseling office.

#### ALTRUSA OFFICE EDUCATION DUE DATE: APRIL 15

The Marjorie Jackson office education scholarship is for \$1000. Must be enrolled at HCC. Based on scholastic record and financial need. Applications in counseling office.

#### HEARTLAND CREDIT UNION SCHOLARSHIP DUE DATE: APRIL 15

Two scholarships at \$2500 each. Must be HCU account holder. See their website at [hcu.coop/scholarship](http://hcu.coop/scholarship). Available in February.

## HHS CTEA BUSINESS SCHOLARSHIP     DUE DATE: APRIL 23

Up to \$500 for an HHS senior with overall GPA of 2.75 and 3.00 GPA in at least three business department classes. Applications available from HHS business department teachers. Includes a resume, two letters of recommendation, and a 500 word essay answering the question “How has Hutchinson High School and the business department prepared you for college and life outside of school”.

## HHS CTEA INTERNSHIP SCHOLARSHIP     DUE DATE: APRIL 23

Up to \$500 for an HHS senior who is an applied business development trainee with an overall GPA of 2.75, 3.00 GPA in at least three business department classes, and has at least one year of active BPA membership. Applications available from HHS business department teachers. Includes a resume, two letters of recommendation, and a 500 word essay that answers the question “How has Hutchinson High School and the business department prepared you for college and life outside of school”.
